

Media Advisory: Important Legislative Action Day This Thursday on Key Homelessness and Housing Issues at the State House

WHAT: The Massachusetts Coalition for the Homeless ("the Coalition") will hold its annual <u>Legislative Action Day</u> this Thursday, February 27th at the State House. The event will mobilize more than 200 families, youth, and adults experiencing homelessness, advocates, providers, legislative cosponsors, and allies to take action in support of key legislative and budgetary campaigns on homelessness and housing issues. The day also will provide an opportunity for legislators, their staff, and the public to learn more about the Coalition's work to prevent and end homelessness in the Commonwealth. State Representative Jim O'Day (D-West Boylston), the House Chair of the Joint Committee on Municipalities and Regional Government, will be hosting Legislative Action Day, and Diane Yentel, President and CEO of the National Low Income Housing Coalition, will provide the keynote address.

A main area of focus will be the Coalition's campaign to increase access to standard-issue Mass ID cards for people experiencing homelessness, currently Senate Bill 2555/House Bill 3066. The bill, originally filed by Senator Harriette Chandler of Worcester and Representative Kay Khan of Newton, would remove cost burdens and excessive verification barriers for people experiencing homelessness when they apply for Massachusetts identification cards through the Registry of Motor Vehicles. Passage and implementation of the bill would allow people experiencing homelessness to more easily apply for jobs, enroll in education programs, get a library card, pick up a package from the post office, open a financial account, enter certain government buildings, and access services. Without a fee waiver, Mass ID cards cost \$25/each, which is cost-prohibitive for many youth and adults without homes. **The Senate version of the bill is scheduled to come up for a vote on Thursday**.

Another top priority for participants is the Coalition's ongoing campaign to permanently re-establish a statewide rental arrearage program by passing An Act to Further Provide a Rental Arrearage Program, House Bill 1264. The bill, filed by Representative Marjorie Decker of Cambridge, recently was reported out favorably by the Joint Committee on Housing and is awaiting its next committee assignment. The rent arrearage bill was cosponsored by 71 other legislators, and currently has been endorsed by 138 organizations across the Commonwealth. The Coalition also has been leading the related budget campaign that was behind successful efforts to create a \$7 million pilot program in the current fiscal year to begin to provide upstream homelessness prevention resources to households that have fallen behind on rent or mortgage payments, but are not yet in the eviction or foreclosure process. This program is called Upstream RAFT, and is part of the larger Residential Assistance for Families in Transition homelessness prevention program (RAFT, line item 7004-9316). Advocates are calling for continued funding and support for Upstream RAFT in FY'21.

Participants also will focus on increasing state funding for housing and wraparound services for unaccompanied youth and young adults who are experiencing homelessness (line item 4000-0007) from \$5 million in FY'20 to \$8 million for FY'21. An \$8 million investment would provide deeper funding for the unaccompanied youth homelessness law, M.G.L. Chapter 6A, Sections 16W and 16X, and better serve and partner with youth and young adults age 24 and younger who are without homes. Funds would be used for housing, wraparound services, and supports for young people experiencing homelessness without a parent or guardian, and to continue the work to build up regional Youth Action Boards, comprised of young people with lived experience of homelessness.

In addition, the Coalition and allies also will push for increased funds and improvements to critical programs such as the Emergency Assistance family shelter and services program (EA, line item 7004-0101), Massachusetts Rental Voucher Program (MRVP, line item 7004-9024 and House Bill 1305/Senate Bill 797), the Emergency Aid to the Elderly, Disabled, and Children program (EAEDC, line item 4408-1000 and House Bill 621/Senate Bill 356), and the Alternative Housing Voucher Program (line item 7004-9030). The group also will ask lawmakers to pass legislation to create a bill of rights for people experiencing homelessness (House Bill 1314/Senate Bill 816), better uphold the safety, dignity, and civil rights of people experiencing homelessness (House Bill 150/Senate Bill 76), ensure that tenants have legal counsel in eviction

proceedings (House Bill 3456/Senate Bill 913), and lift participants in the state's cash assistance programs out of deep poverty (House Bill 102/Senate Bill 36).
