

A Bed for Every Child

Provided **1,598** children with beds and distributed **8,790** age-appropriate books to foster healthy sleep routines, offering opportunities to improve school performance to children living in poverty across **104** communities.



Statewide Systemic Change

Engaged over **3,000** supporters in Call to Actions, leading **7** fundamental policies and helping to advance **16** priority bills to ensure equitable living for all.



The Casa Project

Assisted **1981** households representing **7,924** individuals in the areas of housing stabilization, housing search, maximizing incomes, and creating long-term housing stabilization plans. More than **60,900** hours of Advocacy were provided to households around the Commonwealth and **\$198,457** secured in funding to address housing instability.



Birth to Big Kid Initiative

150 expectant mothers living in poverty received cribs, **2,288** hours of sleep education, and engaged in data collection activities answering **730** questions to improve safe sleep and prevent infant mortality.

Moving forward

As we prepared to sunset the Big Kid Bed Initiative, a final cohort of 350 children between the ages of 2-4 obtained a bed of their own, and parents/guardians were supported with 3,500 hours of sleep education.

As we concluded a programming initiative a public policy campaign started in response to the need for accessible and affordable housing among the low-income older adult population. The Casa Campaign garnered support from 100 legislators to adopt a bridge subsidy to prevent homelessness and displacement as older adults living in poverty move to the top of public housing lists. This campaign will continue to escalate in order to be included in the state budget and implemented statewide.


The Casa Project Demographics

214 Communities


