

Why is it important to pass the Everyone Needs ID Bill: An Act to Provide Identification to Youth and Adults Experiencing Homelessness (Bill H.3388, Bill H.3360, Bill S.2251)?

"The Office of Mayor Michelle Wu proudly supports this piece of legislation and respectfully requests that the Legislature does, as well. In Boston, we are working hard to make homelessness rare, brief, and one-time. Currently existing barriers to identification, however, consume scarce resources and staff time for multiple agencies that provide case management services, including City staff and key partners working with our most vulnerable populations. Hindering service connections and delaying housing navigation efforts, such barriers result in prolonged, preventable, and unnecessary durations of homelessness. In contrast, by removing time-consuming and resource-intensive barriers to identification, this bill stands to expedite service connections and to accelerate individuals' housing searches and overall stabilization."

"Before becoming an Independent/Inclusive Catholic Priest, I myself became homeless for almost 8 weeks in Beverly, MA. I must note that at the time, I did have full time employment which was difficult to maintain due to my not getting a good night's rest. Ultimately, I slept in a "Porta-Johnny" until I was able to receive assistance from my employer to reside in a rooming house. I will never forget those days of darkness. I learned the ways of the street. Now, some 20 plus years later, my Parish helps those who are in need of housing. I volunteer at Haven From Hunger and North Shore Community Action Program assisting individuals in obtaining important documents such as birth certificates, MA ID's & Licenses, etc. Due to my blessed events of the past, I am able to understand what it takes to get out of that vicious cycle of being "unknown" in society. For many of our clients accessing an ID is the first step towards accessing the services they need to break the cycle of chronic homelessness.
