

The number of retirement-age households facing cost burdens has reached an all-time high, and homelessness among older adults is expected to nearly <u>triple</u> by 2030.²



In Massachusetts, older adults make up 39% of extremely low income renter households.³



Older adults living alone in Massachusetts are more likely to face economic insecurity than older adults living alone in any other state.⁴



The cost of living for older adult couples who rent is the highest in Massachusetts (\$51,276, which is 124% of the national average).⁴

- Provide \$60 million in the FY25 state budget to create bridge subsidies for up to 6,000 older adults, aged 60 years and older, facing housing instability to allow them to remain in place while they await approval for long-term subsidized housing, through programs such as state-funded public housing, the Massachusetts Rental Voucher Program (MRVP), the Housing Choice Voucher Program (Section 8).
- Low-income older adults participating in the bridge subsidy program would pay 30% of their income towards rent, with the bridge subsidy making up the difference in the total rent, up to 110% of the fair market rent. The program would be administered by the Executive Office of Elder Affairs (EOEA) in collaboration with the Executive Office of Housing and Livable Communities (EOHLC).
